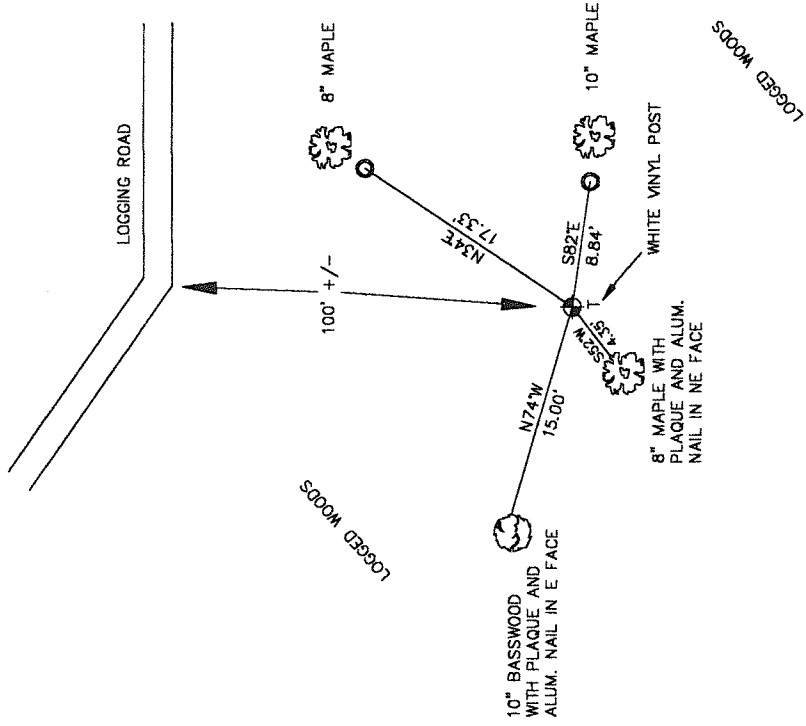
HISTORY OF ORIGINAL CORNER ESTABLISHMENT AND SUBSEQUENT RESTORATION AND DESCRIPTION OF ANY RECORD, MONUMENT OCCUPATIONAL, TESTIMONIAL OR OTHER EVIDENCE CONSIDERED:

The original corner was established in 1857 by James McBride. Original Bearing Trees: Yellow Birch 32" S52W 33lks., Elm 18" N33E 3lks. M. Hutchinson, in the process of his resurvey work, (no date) mentions "stump of original tree standing" at the South 1/4 and recorded 2 new bearing trees, a sugar maple and a basswood. In 1988, William Kelly located a 1" pipe which he accepted as the 1/4 corner and replaced it with a 3" aluminum monument. On 6/27/00, Gerry Bahar and Mark Levitski found the aluminum monument in a logged area and retied.

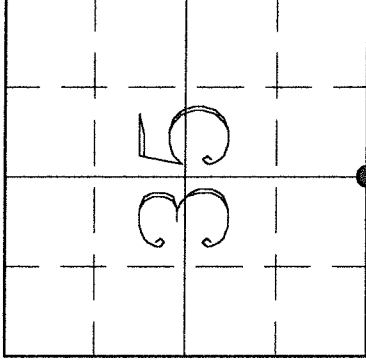

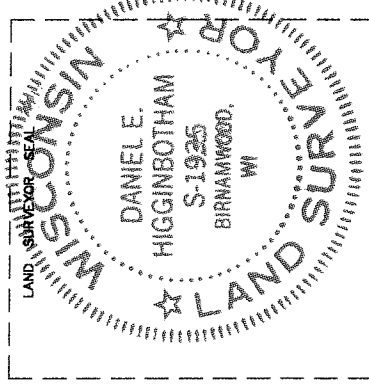
