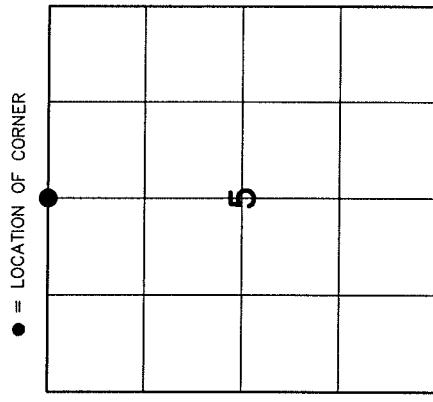

 2017--I FOUND A 2" PIPE WITH ALUMINUM CAP MARKED AS CORNER. ACCEPTED THE POSITION AND SET TIES AS SHOWN

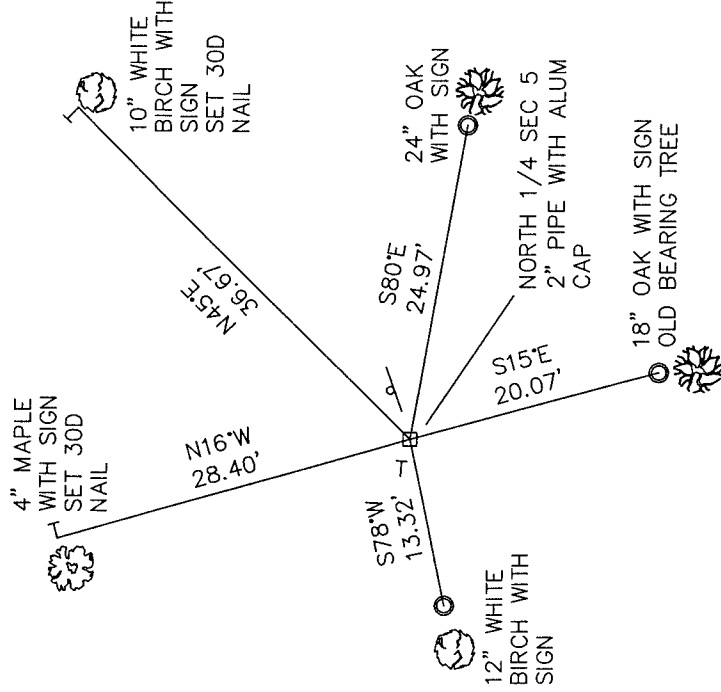

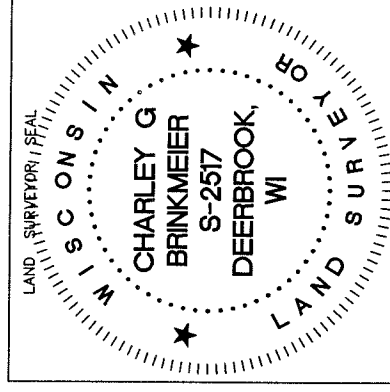
