History of original corner establishment:

Original corner established by H.C. Fellows Gov. Deputy Surveyor in 1859 from which fir 9" bears N4OW 11 1ks and tamarack 13" bears S7OE 18 1ks.

Description of corner evidence found: Re-established section corner running from 1/4 corner between Sections 4 & 5 which Langlade County surveyors recovered in 1938 and re-monumented, to S 1/16 corner between sections 4 & 5 which they established from said 1/4 corner. A distance of 1341.582 ft was measured at bearing \$3-26-35W.

Set section corner on line and doubled distance 2683.164 ft. of 1/4 corner and 1341.582 ft. of S 1/16. Corner falls in south lane of CTH "H".

Recovered a 4" iron pipe filled with concrete and capped with a 4" diameter brass cap stamped: Cor 50 1ks N. on the west R.OW. edge.

This part of CTH "H" has been rebuilt. This witness corner had to be moved for the construction and was not put back in its original position.

Description of monument and accessories I established to perpetuate the original location of this corner.

Set a railroad spike in south lame of CTH "H" for true corner. Changed 50 1ks on old witness corner to read 91.92 1ks.

Marked NBTs to true corner White pine 18" S36E 79.10 ft. Maple 6" S42W 68.59 ft. Scribed 1/4 - B.T.
