

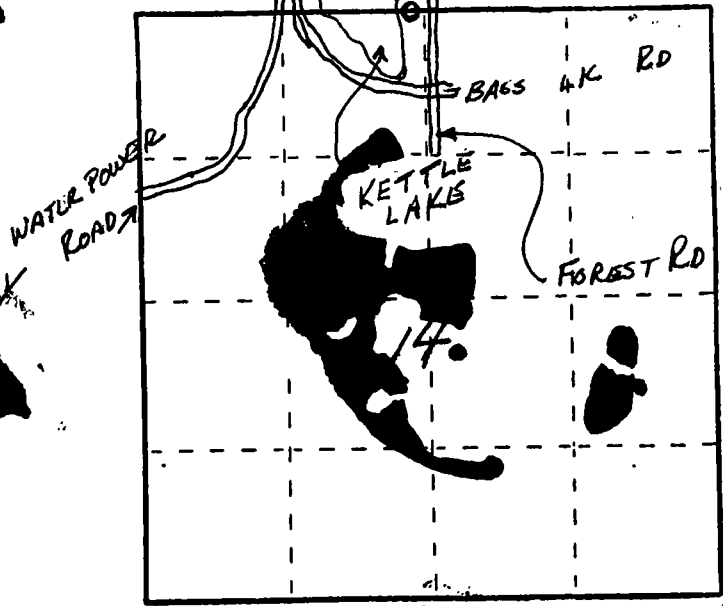
U. S. PUBLIC LAND SURVEY MONUMENT RECORD

 ○ = Corner monument restored.

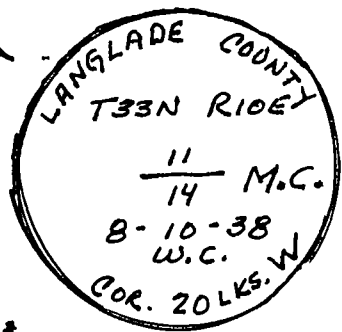

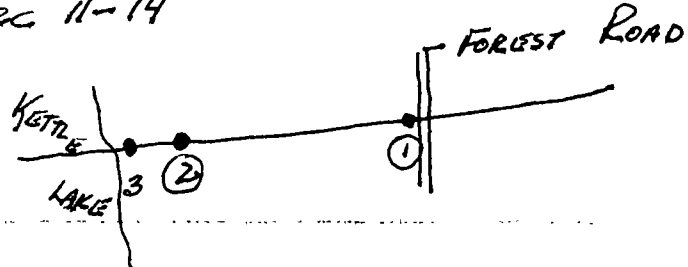

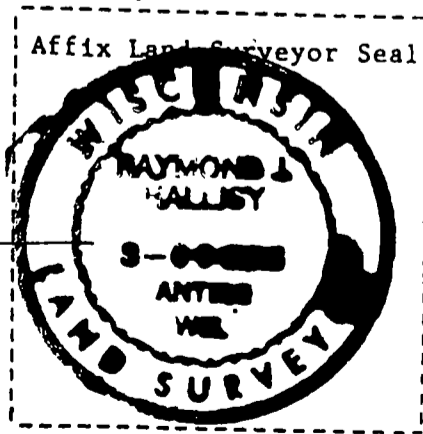
