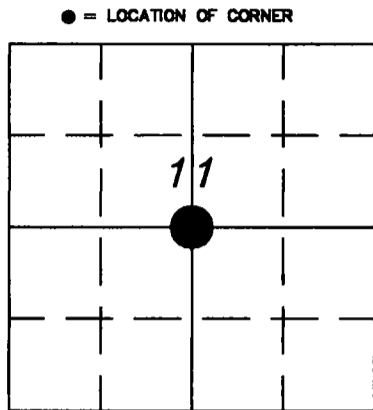


# U.S. PUBLIC LAND SURVEY MONUMENT RECORD

HISTORY OF ORIGINAL CORNER ESTABLISHMENT AND SUBSEQUENT RESTORATION AND DESCRIPTION OF ANY RECORD, MONUMENT OCCUPATIONAL, TESTIMONIAL OR OTHER EVIDENCE CONSIDERED:

This Corner was not monumented in the original Gov't Survey. It appears that previous surveyors mistakenly used the Meander Corner on the East Line of Section 11 approximately 506' North of the East 1/4 Cor location as the East 1/4 Cor. This resulted in Kelly setting a RR Spike in the centerline of Forest Road 251' North of the true protracted Center. Kelly's RR Spike is now being occupied as the Center. On Jan 4, 2001, Dan Higginbotham and Gerry Bahar set an 11/4" Iron Rod at the protracted Center and tied out.



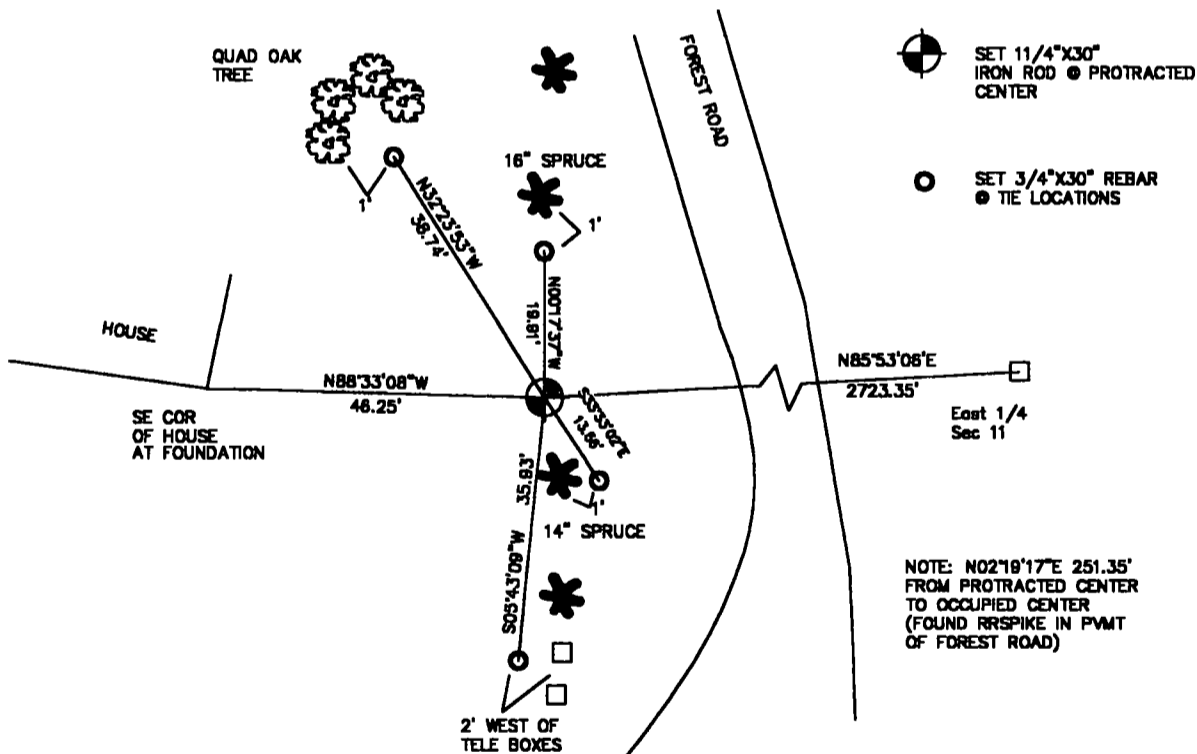
