

Kowalke & Borth in the 1930's re-survey of this township found 2 old stakes down and rotten. Line blazes N-S. OBT's gone. Recorded BT bir. 12", N83°W, 14 is down and rotten, no visible marks. Record BT hemlock, 12", N42½°E, 13 lks. Marked new BO: + on top of grey sandstone, S01½°E, 18.6' and + on N. point of grey rock, S71½°E, 22.8'. 12/28/80 Ray"Hallisy found 4" brass capped iron pipe and marked new BT's. 08/15/96 D. Tlusty after traverse to this area, found 4" iron pipe with brass cap, up .14" above ground. Found south BO stone as described. All of Hallisys' trees are cut and gone, but 2 maple scribed stumps are still visible. Marked new BT's and Accepted iron pipe found as best evidence of the original corner painted all blue.


