
## S. PUBLIC LAND SURVEY MONUMENT RECORD

  - O Corner monument restored.


Quarter Corner Common To Sections 28 and 29, Township 33 North, Range 14 East, Langlade County, State of Wisconsin.

- (b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.
- In 1865, J. L. Nowlin set a wood post with the following corner references: 20" N29°E 15" S55°W 16 1ks. Sugar 18 1ks. Sugar
- In 1989, John Schulke found 6"X6" square cedar post extending  $4\frac{1}{2}$  ft. from the ground with a metal location tag. Found stump holes N29°E 11.9 ft. and S55°W 10.6 ft. Found 8"X8" square wood post N0°05'E a distance of 1299.5 ft. (Set as N 1/16 of Sections 28 and 29.) I accept the position of the wood post as the best available evidence of the original corner.
  - In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

    Describe witness monuments.
  - Show a plan view drawing depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
- 2 1/2" dia. X 36" aluminum magnetic cap monument stamped to identify the corner.
- 7" N58°W Sugar Maple 11.35 ft.
- 6" NO8°E 3. Sugar Maple 36.52 ft.
- 7" S56°E 21.60 ft. 4. Sugar Maple
- Sugar Maple 10" S13°W 11.30 ft.
- Steel sign post Northeast 0.7 ft. 6.



(a) Describe any material discrepancy between the location of the corner as restored or reestablished and the location of that corner as previously restored or reestablished by distance and direction. Show the discrepancy on the plan view drawing under (d), above. Show the distances between the corner as previously restored or reestablished and (1) the corner as restored or reestablished, and (2) to at least 2 of the vitness monuments shown on the drawing in (d), above.


