

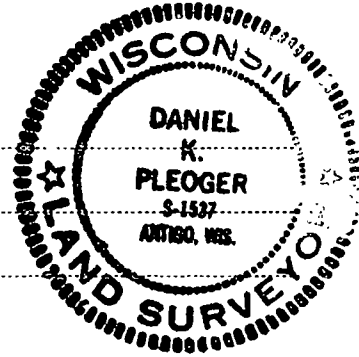

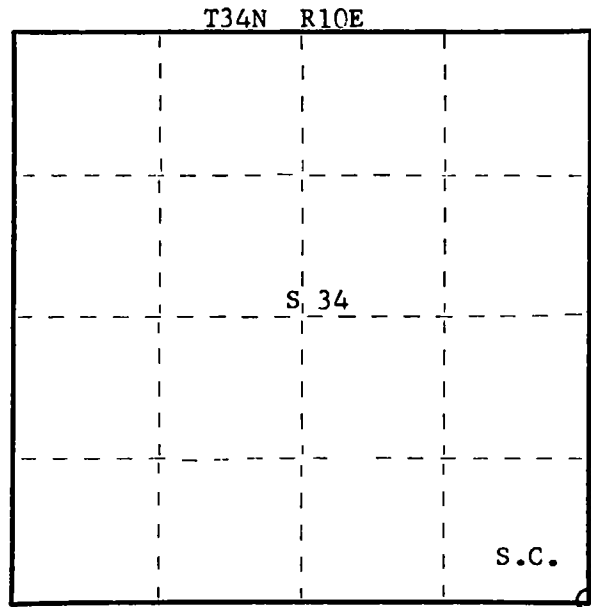

Pleoger, do hereby certify that on the 17th day of September, 1980, I found evidence of the Section corner of sections 34-35, 3-2 Township 34 and 33, North, Range 10 East, Fourth Principal Meridian, as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner.

History of original corner establishment:  
Corner established by B.F. Dorr, County Surveyor, in 1882 from which Tamarack 14" bears N5°W 36-1/2 links and Tamarack 12" bears S58°W, 8-1/2 links.  
Corner recovered in 1937 by Langlade County surveyors.  
A galvanized pipe set by county surveyors.

Spruce 7" N6-1/2°E 37.8 links  
Tamarack 9" S79°E 77.8 links  
Tam.Stub 10" S66°W 24.7 links

Description of corner evidence found:  
Recovered a 4" iron pipe with screw-on iron cap, stamped:  
Monument projecting 18" above ground.  
OBT's - Dorr's Tam.stp. S5°W 5.75 links, rotted stump remains  
Tam.stp. 8" N26°W 15.00 links, rotted stump remains.  
OBT's - County's Spruce 7" N6°E 37.8 links - cut stump.  
Tam. 9" S79°E 77.8 links - 6 ft. snag remains  
Tam. stub 10" S66°W 24.7 links - snag remains, scribed S3-BT.
