


THE ORIGINAL QUARTER CORNER WAS ESTABLISHED IN 1859 BY HIRAM C. FELLOWS. ORIGINAL BT'S: TAMARAC 10" N29W 13LKS., FIR 14" S70W 35LKS. SUBSEQUENT RESURVEY NOTES INDICATED A STONE TO BE IN PLACE AT THIS CORNER. CHARLEY BRINKMEIER AND GERRY BAHAR SEARCHED FOR THIS CORNER AND FOUND ONLY THE WITNESS MONUMENT.IN 1996, DAVE TLUSTY, LANGLADE CO SURVEYOR, DUG FOR THIS CORNER AND FOUND WHERE THE STONE HAD BEEN. A 1 1/4"X30" IRON ROD WAS SET AT THIS LOCATION AND WAS TIED OUT.
