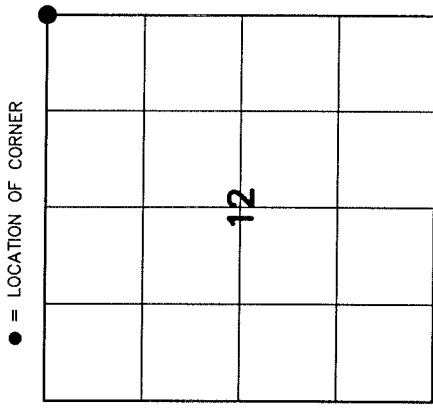

2016—I FOUND THE 2" PIPE WITH THE BRASS CAP AND SET TIES AS SHOWN

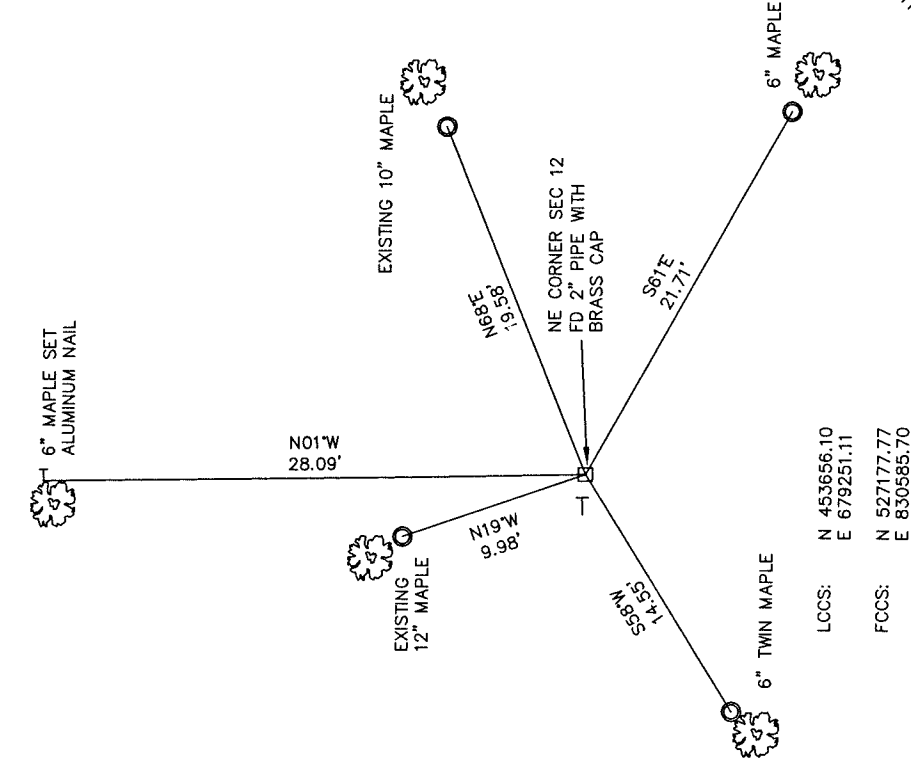

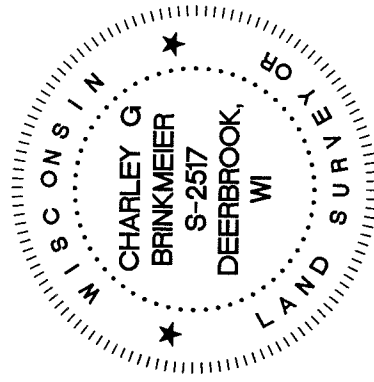
