Hall set a new iron pipe from the original birch BT. Scribed a cedar post and marked NBT's - Hemlock 11" S2 E 27-1/2 links; Hemlock 20" N54-1/2 W 54.7 links; original Birch 26" N40 W 10 links.

Description of corner evidence found:
