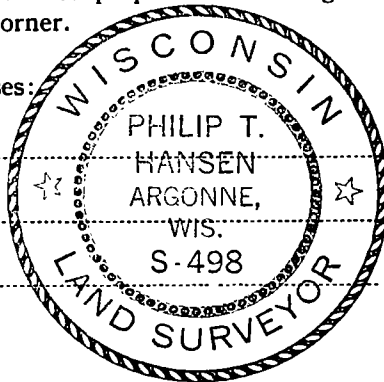

Hansen, do hereby certify that on the 7th day of April, 1976, I found evidence of the Section corner of Sec. 32-33-5-4 Township 34 & 35, North, Range 11 East, Fourth Principal Meridian, as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner.

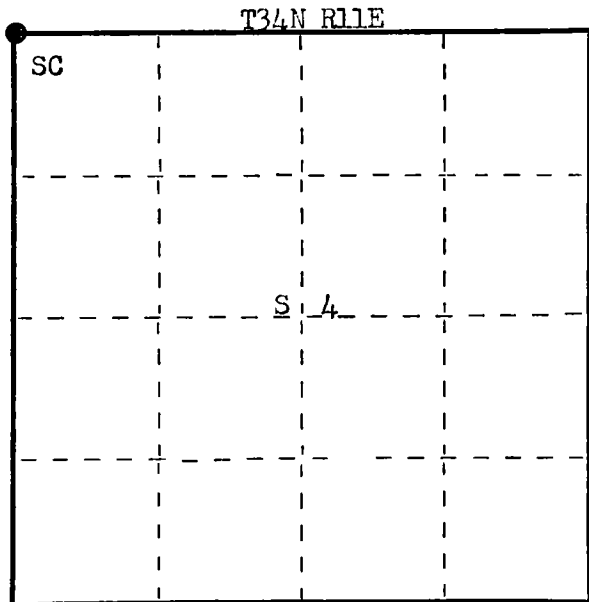

History of original corner establishment: Original corner established by Hiram C. Fellows, Deputy Surveyor, in 1859, from which W. Pine 16" bears N32°E, 8 lks, white pine 14" bears S68°E 9 lks, Hemlock 9" bears N50°W 21 lks and Hemlock 8" bears S41°W 24 lks. Corner recovered by Vaughn in 1901, but the original BTs as called for did not correspond to the BTs recovered.

Corner recovered by H.C. Lawrence in 1952. No record of who established the corner, but may have been Chas. Borth. This corner has been recognized for years. Set a 5" cedar post, and marked NBTs - Y. Birch 10" N60°E 84 lks and Maple 8" S89°E 30 lks.

Description of corner evidence found: Recovered 5" cedar post, squared and scribed S4, S5, S32 and S33 in fair condition. Found a rock cairn around base. Recovered OBT, Yellow Birch 10" N60°E 84 lks, now a decayed stump, Maple 8" (10") S89°E 30 lks. scribed S4, bottom scribe grown over.

Description of monument and accessories I established to perpetuate the original location of this corner.

Replaced wood post with 2 1/2" iron pipe with brass cap, stamped.

Post projects 2' above ground.

NBTs - Maple 7" S63°W, 64.9 lks, scribed SC BT.

Maple 6" S47°E, 29 lks scribed SC BT.

No others suitable for BTs.

Replaced rock cairn around base of monument.

Pipe and BTs painted blue.
