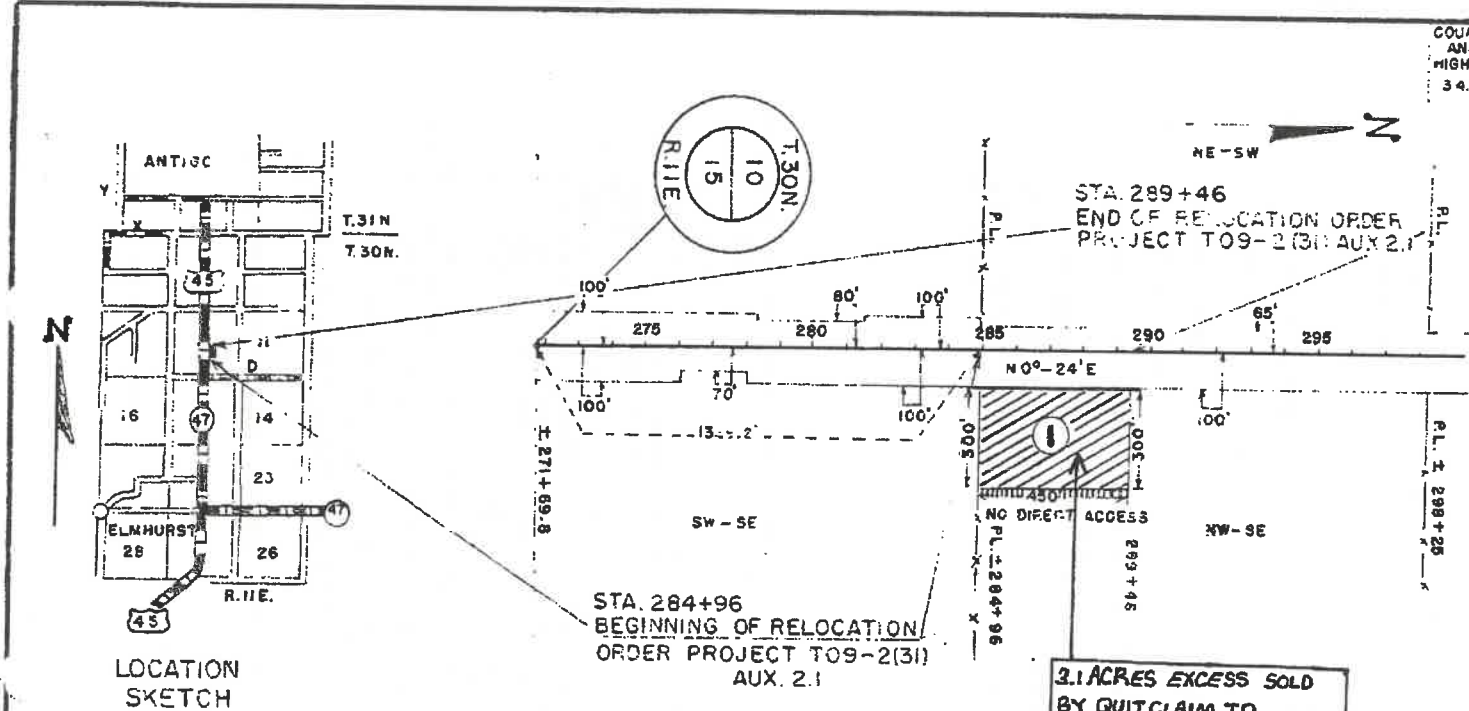

to State of Wisconsin (Highway Commission)
of County, Wisconsin,
grantee for the sum of One thousand and no/100 (\$1,000.00)

Fee Title in and to the following tract of land in Langlade County, State of Wisconsin, described as:

In T. 30N., R. 11E., Section 10, NW 3/4 thereof.

A strip of land therein, being 300 feet in width and lying between lines 100 feet and 400 feet easterly of and parallel to the following described reference lines:

Commencing at the south quarter corner of said Section 10,

Thence N. 0°-24'E. approximately 1326.2 feet to the south line of said NW 3/4-SE 1/4,

Section 10 and point of beginning of the aforescribed strip of land,

Thence containing N. 0°-24'E. approximately 450 feet to the end of the aforescribed strip of land.

ALSO acquired herein is the right of access, including all existing, future or potential common law or statutory easements or rights of access between any traveled way of U.S. Highway 45, and the aforescribed 450 foot strip of the said NW 3/4-SE 1/4 where it abuts upon said highway.

Said strip of land contains 3.10 acres, more or less, exclusive of land previously acquired or now used for highway purposes.

The consideration stated herein is payment in full for the property described herein and includes full compensation for items of damage set forth in sec. 32.09, Wisconsin Statutes, assuming the completion of the improvements contemplated by the relocation order or orders upon which this instrument is based.

Compensation for additional items of damage listed in sec. 32.14, Wisconsin Statutes, has not been included. If any such items are shown to exist the owner may file claims as provided in sec. 32.20, Wisconsin Statutes.
