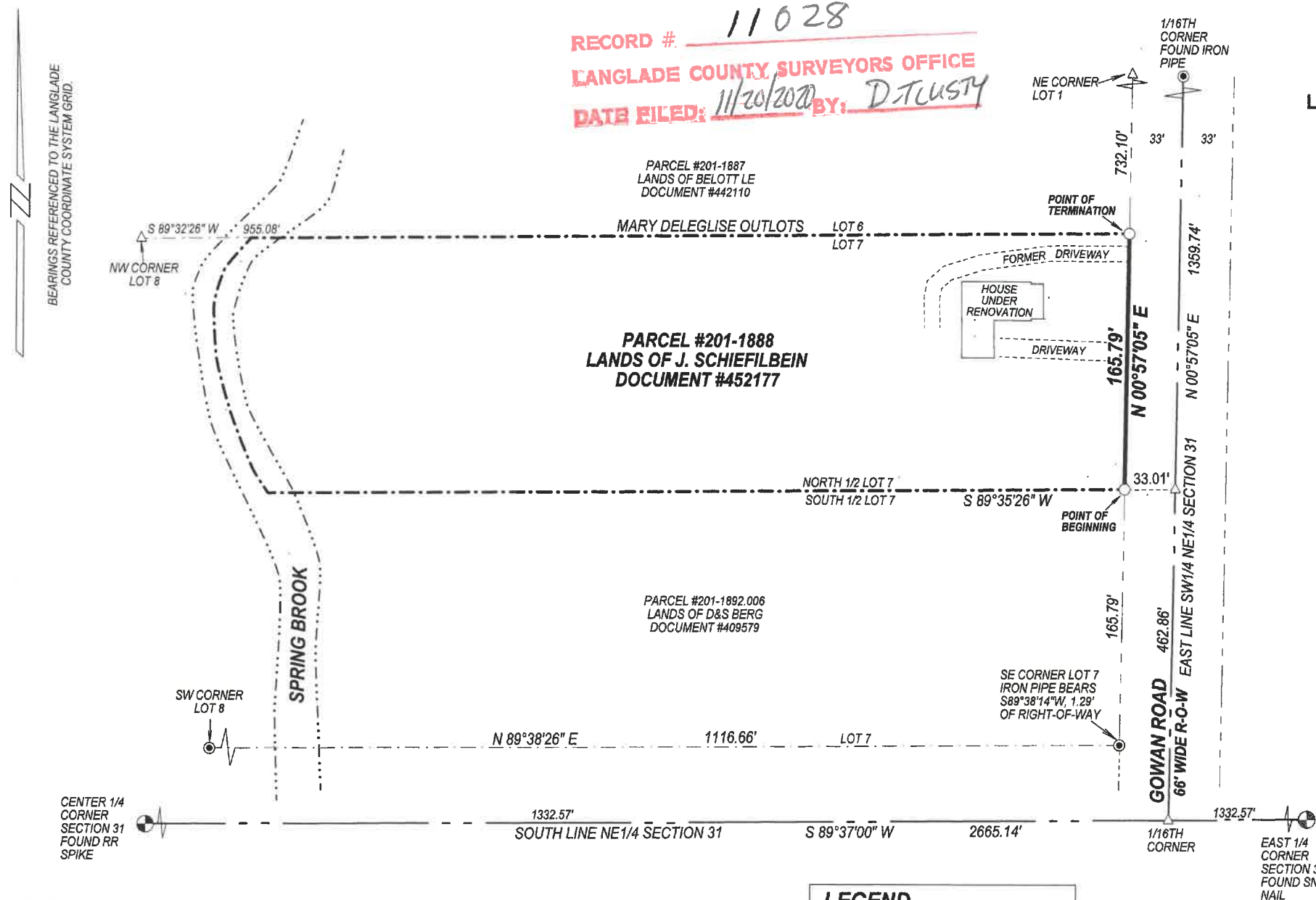

 NE1/4 OF SECTION 31, T31N-R11E.

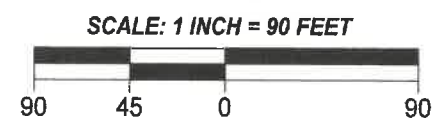
