I, TIMOTHY J. RUSCH, PROFESSIONAL LAND SURVEYOR, DO HEREBY CERTIFY:

THAT I HAVE SURVEYED AND MAPPED BY THE ORDER OF DEREK MURASKI, A PARCEL DESCRIBED IN DEED #436368, LOCATED IN GOVERNMENT LOT 5, SECTION 2, T34N-R11E.

DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTH 1/4 CORNER OF SECTION 2: THENCE S02°01'56"W, ALONG THE EAST LINE OF THE NW1/4 OF SAID SECTION, 1496.09 FEET: THENCE N89°54'03"W, 1270.16 FEET TO THE POINT OF BEGINNING: THENCE ALONG THE WESTERLY RIGHT-OF-WAY OF PINE LANE, 55.87 FEET. ALONG A CURVE TO THE LEFT WITH A CENTRAL ANGLE OF 10°41'49", A RADIUS OF 299.26 FEET, A CHORD BEARING OF \$05°16'05"E AND CHORD LENGTH OF 55.79 FEET; THENCE S79°38'34"W. 193.15 FEET TO A MEANDER CORNER WHICH LIES N79°38'34"E, 30 FEET MORE OR LESS FROM THE APPROXIMATE ORDINARY HIGH WATER MARK OF UPPER POST LAKE; THENCE N19°17'52"W, ALONG A MEANDER LINE, 96.05 FEET TO A MEANDER CORNER WHICH LIES S89°54'03"E, 30 FEET MORE OR LESS FROM SAID APPROXIMATE ORDINARY HIGH WATER MARK; THENCE S89°54'03"E, 216.62 FEET TO THE POINT OF BEGINNING. INCLUDING THE LANDS BETWEEN THE MEANDER LINE AND APPROXIMATE ORDINARY HIGH WATER MARK BETWEEN THE LOT LINES EXTENDED AS SHOWN ON MAP HEREWITH.

THAT THIS SURVEY WAS FOR THE PURPOSE OF LOCATING PROPERTY BOUNDARIES ONLY. OTHER GEOGRAPHICAL FEATURES WERE NOT MAPPED.
