PARCEL "A" DESCRIPTION

Part of the NE1/4 NE1/4 of Section 33, T34N-R10E, Langlade County, Wisconsin; being more particularly described as follows:

Commencing at the Northeast Corner of Section 33; Thence S00°06'02"E, along the East line of the NE1/4 of said Section, 224.55 feet; Thence S59°33'00"W, 684.74 feet to the Point of Beginning; Thence S34°24'19"E, 112.20 feet; Thence S58°51'48"W, 20.00 feet; Thence N61°37'21"W, along the easterly line of Lot 1 of Certified Survey Map Volume 1 Page 106, 131.10 feet; Thence N59°33'00"E, 80.12 feet to the Point of Beginning. Said parcel contains 5,614 square feet.

This parcel to be combined with Lot 1 of Certified Survey Map Volume 1 Page 106. This parcel is not a stand-alone buildable parcel.

PARCEL "B" DESCRIPTION

Part of the NE1/4 NE1/4 of Section 33, T34N-R10E, Langlade County, Wisconsin; being more particularly described as follows:

Commencing at the Northeast Corner of Section 33; Thence S00°06'02"E, along the East line of the NE1/4 of said Section, 224.55 feet; Thence S59°33'00"W, 684.74 feet; Thence S34°24'19"E, 112.20 feet to the Point of Beginning; Thence S34°24'19"E, 111.19 feet; Thence S68°24'27"W, 20.00 feet; Thence N34°39'09"W, along the easterly line of Lot 4 of Certified Survey Map Volume 1 Page 104, 107.90 feet; Thence N58°51'48"E, 20.00 feet to the Point of Beginning. Said parcel contains 2,161 square feet.


This parcel to be combined with Lot 1 of Certified Survey Map Volume 1 Page 104. This parcel is not a stand-alone buildable parcel.
